GENERAL

By purchasing a ticket, purchasers acknowledge that they have read, understood, and agreed to all the Terms and Conditions. All inquires regarding the conduct, chance of winning, prizes or procedures of the raffle are to be made to the Greek Community of Niagara – Greek Orthodox Church of St. Catharines and District prior to the purchase of a ticket.

By claiming a prize, the winner consents to:

- The use of their photograph, first and last name, ticket number, city/town of residence and the audio/video recording (or written transcription) of the winner notification.
- Telephone call/email, for any publicity purposes by GCN; and
- With respect to compliance by GCN with any terms of the lottery licence and for any other purposes GCN considers appropriate in the administration and promotion of the lottery (all without any further notice, review or approval or additional compensation to any winner or winners).

ELIGIBILITY

Only tickets that have been paid for and/or have been verified as paid for are eligible to be entered into the draw.

<u>Age</u>: Participants must be at least 18 years of age to be eligible to purchase a ticket. Tickets cannot be purchased in the name of a minor.
